The first few months of 2011 we met at Sullivan's restaurant. While the food was excellent, the service and size of the room left much to be desired.

# Women of Wounded Warriors Celebration

On February 24<sup>th</sup>, several ARW ladies participated in the Women of Wounded Warriors Celebration in San Antonio. This celebration of the wives and mothers of Brooks Army Medical Center (BAMC) Marine Corps Wounded Warriors was a night to remember for those who were honored and those fortunate enough to help with the event.

Two dozen wives and mothers plus several sisters and friends were pampered for the evening at the event at Saks Fifth Avenue in San Antonio. The event was coordinated by Stephanie Barnes, wife of LtCol David Barnes, MC Unit Commander. All of the spouses and mothers currently have husbands or sons who are at BAMC for an extended period for treatment following severe injuries sustained in Iraq and Afghanistan. Also recognized was a Gold Star mother and her daughter who lost her son last year at this time.



BAMC is reserved for the worst injuries Marines receive in these wars - from severe burn injuries to severe amputations. When this happens, Marines have to heal and learn how to live with their injuries. This emotional and physical healing and rehabilitation processes can take years to accomplish.

Wives, children and parents suffer alongside their loved ones throughout the process. One family member is afforded the opportunity to stay with each wounded Marine. Parents or wives often lose their jobs during this trying time. Children are often relocated to go to school

locally around BAMC. These family members make sacrifices on a daily basis. LtCol Barnes recognizes the sacrifices made, and also stresses that the families are as important to the injured Marine's recovery as all the healing benefits that the latest medical treatments can provide.

The Women of Wounded Warriors Celebration was a fun, uplifting evening during which all the women were able to forget their difficult situations for a while. They had hair and makeup done by Saks Fifth Avenue stylists. Also, the Saks makeup consultants served a light dinner and poured wine.

While everyone visited, laughed and occasionally shed a tear, LtCol Barnes and Stephanie drew for raffle gifts for all of the honored women. Each of the wives and mothers then received a gift certificate for \$400 and a 'goodie bag', and then went shopping!

The raffle gifts, goodie bag items and gift cards were all donations from generous individuals and organizations. ARW contributed to the gift cards, and our own Marjie Walters and Carol Cates contributed many items to both the raffle and goodie bags. A very big THANK YOU to all of you who contributed and made this an incredible evening.
